I also realize that if I avail myself of child care before or after the Program, I am giving permission for my child to be on the premises without full staff supervision and children are subject to the rules and regulations of this activity; i.e., to remain in the HOUSE, TACK ROOM or OFFICE and not be outside in the pool area, the barn area or in the fields around the barn.

Deposit

A deposit of \$325 for each session to be attended is required. The balance of the session is due on or before the first day of each session. **Deposits are not refundable for any reason.**

Refund policy

Riding session fees paid in advance are refundable only upon presentation of a medical certificate from a licensed physician. **The deposit fees are not refundable for any reason.**

Insurance

Participants must be covered under a family medical insurance plan whose name shall be listed on the application form. Out-of-state participants must produce immunization records as required by the State of Maryland.

What to bring

Riders should bring a bag lunch, extra clothes and riding gear. Water, drinks and afternoon snacks are provided between lessons.

Licenses: Clay Hill is fully licensed by the State of Maryland and by Prince George's County and all Instructors are certified as Riding Instructors as well as in CPR Tax ID # 21-3786459

Staff ratio

Series enrollment is limited to 24 riders per session. Ratio of students to staff is 6 to 1

Extras

Qualified participants may have the added experience of showing at a local show and/or may be invited to experience trail rides, field trips or overnights. Just remember the Horsemanship Adventure Series is designed to educate young riders, therefore not all participants may enjoy all phases of horse care and maintenance.

Clay Hill is in its 35th season of successful horsemanship programs.

We are very proud of all our "graduates" who have enjoyed the in-depth experience of our camps and welcome many of their children back. The Horsemanship Adventure Series is an entirely hands-on, educational riding program. Every participant is assigned a horse or pony of his/her own to take care of and learn to ride in at least 2 lessons each day.

About our horses

The Clay Hill horses and ponies are of impeccable quality and are well-trained and child-oriented at all levels. You may meet our equine friends at local horse shows and events.

For your convenience...

Children may arrive as early as 7:00 a.m. at an additional charge of \$30 per week. They may also stay as late as 6:30 p.m. at an additional charge of \$30 per week. Children not picked up by 5:00 may be invited to swim in the family pool as a guest with parental permission, but the swimming pool is off-limits during the riding lesson programs.

Application deadlines

All applications should be submitted on or before April 15, 2009. Fee for the full summer of riding lessons is \$1600.00 A 10% discount may be taken for each additional child in the same family attending the same session only. Counselors-in-training (CIT) must attend one session in the lesson program before they are eligible for the CIT program. Tuition for Senior (Age 16) CIT's after that time is \$50 per week - Junior CIT's pay normal riding fees.

Registration fees

\$325 for any one week; \$450 for two-week session (consecutive dates as stated only).
